**EXTENSION OF SUSPENSION OF ACTIVITIES JUDICIAL COURTS**



April 23, 2020

As a result of Covid-19 pandemic and to this day, judicial courts have extended their period of work suspension in the following terms (with the general exception of criminal and family courts).

**I. ANNOUNCEMENTS OF EXTENSION OF WORK SUSPENSION AT A FEDERAL LEVEL:**

**National Supreme Court of Justice.**

Through announcement number 57/2020, dated April 13, 2020, the National Supreme Court of Justice decreed the extension of the work suspension. The period of suspension of work is from March 18 to May 5, 2020.

During the period mentioned above, no meetings, hearings or procedural deadlines will be held. There will be only one guard to receive urgent constitutional disputes requesting suspension.

**Federal Judicial Authority.**

Through announcement number 06/2020, dated April 13, 2020, the Federal Judicial Authority ordered to extend the suspension of jurisdictional work of the Federal Judicial Authority's entities. The period of work suspension will be from March 18 to May 5, 2020.

During the period mentioned above there will be no procedural deadlines and there will only be one guard for matters requiring urgent attention.

**Federal Court of Administrative Justice.**

Through announcement SS/11/2020, the Federal Court of Administrative Justice determined an extension to the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**II. ANNOUNCEMENTS OF EXTENSION OF WORK SUSPENSION AT A LOCAL LEVEL:**

**Mexico's City Judicial Authority.**

Through announcement dated April 13, 2020, in compliance with Agreement 03-15/2020, issued by Mexico City's Superior Court of Justice, it was ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Administrative Justice Court of Mexico City.**

Through announcement dated April 13, 2020, the Administrative Justice Court of Mexico City ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**State of Mexico's Judicial Authority**

Through announcement number 19/2020, dated March 31, 2020, the Judicial Authority of the State of Mexico ordered the extension of the suspension of jurisdictional work, which began on March 20, 2020 and will continue until April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Nuevo León State Judicial Authority.**

Through announcement number 7/2020-II, the Superior Court of Justice of the State of Nuevo León ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Jalisco State Judicial Authority.**

Through announcement dated April 17, 2020, the Judiciary Council of the State of Jalisco, ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Aguascalientes State Judicial Authority.**

Through announcement dated April 16, 2020, the Supreme Court of Justice of the State of Aguascalientes ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 19 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Baja California State Judicial Authority.**

Through an agreement signed on April 14, 2020, the Judicial Authority of the State of Baja California ordered to extend the suspension of jurisdictional and administrative work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Baja California Sur State Judicial Authority.**

Through announcement dated April 12, 2020, the Judicial Authority of the State of Baja California Sur ordered an extension of the suspension of jurisdictional and administrative work. The period of work suspension is from March 20 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Campeche State Judicial Authority.**

Through announcement dated April 16, 2020, the Judicial Authority of the State of Campeche ordered an extension of the suspension of jurisdictional and administrative work. The period of work suspension is from March 23 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Chiapas State Judicial Authority.**

Through announcement number 04/2020, the Judicial Authority of the State of Chiapas, ordered an extension of the suspension of jurisdictional and administrative work. The period of work suspension is from March 19 to May 5, 2020.

**Chihuahua State Judicial Authority.**

Through announcement dated April 17, 2020, the Judicial Authority of the State of Chihuahua, ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 19 to April 30, 2020.

**Colima State Judicial Authority.**

Through announcement dated April 17, 2020, the Judicial Authority of the State of Colima ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 19 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Durango State Judicial Authority.**

Through announcement dated April 2, 2020, the Judicial Authority of the State of Durango ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Guanajuato State Judicial Authority.**

Through announcement dated April 14, 2020, the Judicial Authority of the State of Guanajuato ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 21 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Guerrero State Judicial Authority.**

Through announcement dated April 6, 2020, the Judicial Authority of the State of Guerrero ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Hidalgo State Judicial Authority.**

Through announcement number 03/2020, the Judicial Authority of the State of Hidalgo ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 19 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Michoacán State Judicial Authority.**

Through announcement dated April 7, 2020, the Judicial Authority of the State of Michoacán ordered to extend the suspension of jurisdictional work. The period or work suspension is from March 19 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Morelos State Judicial Authority.**

Through announcement number 002/2020 dated April 16, 2020, the Judicial Authority of the State of Morelos ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020, resuming work on May 6.

During the period mentioned above, no procedural deadlines will apply.

**Nayarit State Judicial Authority.**

Through announcement dated April 16, 2020, the Judicial Authority of the State of Nayarit ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Oaxaca State Judicial Authority.**

Through General Joint agreement 4/2020, the plenary sessions of the Superior Court of Justice and the Judiciary Council of the State of Oaxaca, ordered to extend the suspension of jurisdictional work. The suspension period is from March 20 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Puebla State Judicial Authority.**

Through announcement dated April 14, 2020, the Judicial Authority of the State of Puebla ordered to extend the suspension of jurisdictional work. The suspension period is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Querétaro State Judicial Authority.**

Through announcement dated April 6, 2020, the Judicial Authority of the State of Querétaro ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 21 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Quintana Roo State Judicial Authority.**

Through announcement number 3/2020, the Judicial Authority of the State of Quintana Roo ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 19 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.

**San Luis Potosí State Judicial Authority.**

Through announcement, the Judicial Authority of the State of San Luis Potosí ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Sinaloa State Judicial Authority.**

Through an official communiqué dated April 16, 2020, the Judicial Authority of the State of Sinaloa ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 19 to May 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Sonora State Judicial Authority.**

Through announcement dated March 25, 2020, the Judicial Authority of the State of Sonora ordered to extend the suspension of jurisdictional work. Jurisdictional work will be restored when the State's Ministry of Health considers it appropriate.

During the period mentioned above, no procedural deadlines will apply.

**Tabasco State Judicial Authority.**

Through announcement number 02/2020, the Judicial Authority of the State of Tabasco ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 20 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Tamaulipas State Judicial Authority.**

Through announcement number 02/2020, the Judicial Authority of the State of Tamaulipas ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to April 30, 2020.

**Tlaxcala State Judicial Authority.**

In compliance with the agreement reached in an extraordinary session, dated April 15, 2020, the Judiciary Council of the State of Tlaxcala ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 23 to April 30, 2020.

During the period mentioned above, no procedural deadlines will apply.

**Veracruz State Judicial Authority.**

Through announcement number 7, dated April 16, 2020, the Judicial Authority of the State of Veracruz ordered to extend the suspension of jurisdictional work. The period of work suspension is from March 18 to May 5, 2020.

During the period mentioned above, no procedural deadlines will apply.
